National Gender and Development (GAD) Planning and Budgeting Conference Towards Enhancing the DOLE GAD 2014-2016 Planning Tool
A Concept Paper

- I. **Objectives.** The proposed one-week activity intends to provide all DOLE Reporting Units with tools and guidance in planning toward implementing a more gender-responsive policies, programs and projects.

Specifically, it aims to:

1. Promote understanding of GAD;
2. Provide guidance in the following:
 - identifying programs, activities, and projects (PAPs) that are gender-responsive;
 - formulating DOLE GAD performance indicators; and
 - accomplishing prescribed/required GAD-related reports/documents and forms.
3. Address emerging issues and concerns in the implementation of DOLE GAD policies, programs, and projects.

- II. **Methodology.** The five-day Conference proposes to hire GAD Resource Persons/Consultants and are expected to come up with a training design in consultation with DOLE GAD TWG. The conference shall utilized interactive approach (i.e. open forum/discussion and workshops).

GAD Personalities/Advocates shall be invited to share their experiences and expertise on GAD.

- III. **Proponents.** The Conference is being proposed by DOLE-GAD TWG composed of AS, FMS, HRDS, IAS, LCO, PS and BLES/PSA).

- IV. **Expected Output.** The conference expects to produce the following:

1. DOLE-GAD 2014-2016 Planning Tool
2. Agency's 2014-2016 GAD Plans and Budget;
3. Draft DOLE-GAD Website; and
4. Action Plan to address issues and concerns.

- V. **Participants.** All DOLE Reporting Units' GAD Focal and Alternate Persons

- VI. **Proposed Schedule and Venue.** This will be a **five (5)-day** activity proposed to held on 05-09 May 2014.
